Automotive Technology

In Automotive Technology, a threeyear program, students learn all phases of maintenance and repair. This course is designed to provide a basic understanding of automotive systems, equipment, and industry standards. All students will receive extensive theory instruction and actual "hands-on" tactile experience on late model vehicles to prepare them for careers in the high paying, fast changing automotive industry. The program provides the students with access to the latest equipment and computer-based reference material. Upon completion of this program students that are eligible will have the opportunity to obtain their State inspection license.

Cooperative Education

During a student's senior year, they may be eligible to participate in a supervised Cooperative Education on-the-job training program with a local business or industry in the Corry area.
